Prior to joining the Chamber, Jon served as an advisor to Senator Rubio for 3.5 years. In addition, he served as the Senator's primary DC liaison for all state and local government officials in the state of Florida and he advised the Senator on various banking and housing issues. He obtained his J.D. from the University Of Miami School Of Law and he completed his undergraduate education at Syracuse University where he majored in both Economics and Political Science and was a member of the Syracuse Orange football team.
